

NetMetal series

The NetMetal is a solid and waterproof outdoor device. It has a high power wireless interface, and one Gigabit Ethernet connector, which support MDI-X auto detection. The device has two or three RP-SMA connectors for connecting external antennas (depends on model). The device is packaged with a 24 V power adapter, a PoE injector and two mounting loops. There are four models available – two Three-chain devices (with miniPCIe slot and without), and two Dual-chain models (with miniPCIe slot and without). Extra places for more RP-SMA connectors are available on the unit in this case.

First use

1. Remove the lid, and connect the antenna to the RP-SMA connectors. Bend the cable with a large radius, so that it will be able to exit through the cable openings in the bottom of the lid. Put the lid back.
2. Open the product bottom door, to reveal the Ethernet connector.
3. The device accepts 12-28 V Passive PoE from a PoE injector (please compensate voltage for loss due to cable length)
4. The default IP address from Ether1 is 192.168.88.1 for configuration, username is admin and there is no password.
5. Please choose your country to comply with local regulations. We suggest to also choose to upgrade the device in the screen that loads. Make sure that you have set a password for the WiFi network and the router itself.
6. Depending on the antenna used, you must set its gain in the RouterOS software to ensure that EIRP meets the limit set by the local authorities. This is done in the Wireless menu.
7. If your unit comes equipped with a spare miniPCIe slot (depends on model), open the NetMETAL case to install the additional miniPCIe card. There are places for extra RP-SMA cables in the top of the device, you will use a 6.5mm drill to open up the places for the extra RP-SMA cables in the marked locations.

Mounting

To tighten the device to a pole, use the provided metal hose clamp. Guide the loop around the device through the provided holes, and around the pole where it will be mounted. You should avoid connecting a loose Ethernet cable to the Ethernet port—secure the cable to a wall or the pole, so that the cable weight is not pulling the port. It is recommended to secure the Ethernet cable less than 2 m from the device. This is to ensure that the cable doesn't damage the port by its weight, or doesn't fall out. It is possible to connect grounding wires to the PCB board mounting holes, but to do this, you must remove the PCB from the case.

Powering

The ethernet port accepts passive Power over Ethernet 8-30 V DC. Package contains a 24 V adapter and a PoE injector. Maximum power consumption of the device is 21 W at 24 V.

Configuration

The device is configured as a wireless access point, with the ethernet port configured as a DHCP client, for connecting to your ISP router or switch. A DHCP server is configured on the wireless interface.

RouterOS includes many configuration options in addition to what is described in this document. We suggest to start here to get yourself accustomed to the possibilities: <http://mt.lv/help>.

In case IP connection is not available, the Winbox tool (<http://mt.lv/winbox>) can be used to connect to the MAC address of the device from the LAN side (all access is blocked from the internet port by default).

Expansion Slots and Ports

- Built in 5GHz 802.11ac/a/n wireless, AP/station/bridge modes supported (for CPE, AP, PtP modes)
- One 10/100/1000 Gigabit Ethernet port, supporting automatic cross/straight cable correction (Auto MDI/X), so you can use either straight or crossover cable for connecting to other network devices. The Ethernet port accepts 8-30 V DC powering from a passive PoE injector.
- One USB 2.0 or 3.0 port (depends on model) for extra storage or 3G/4G modem

Buttons and Jumpers

The reset button has three functions:

- Hold this button during boot time until LED light starts flashing, release the button to reset RouterOS configuration (total 5 seconds).
- Keep holding for 5 more seconds, LED turns solid, release now to turn on CAPs mode for managing the unit from a CAPsMAN server (total 10 seconds).
- Or Keep holding the button for 5 more seconds until until LED turns off, then release it to make the RouterBOARD look for Netinstall servers (total 15 seconds).

Operating System Support

The device supports RouterOS software with the version number at or above what is indicated in the RouterOS menu `/system resource`. Other operating systems have not been tested.

We recommend clicking the “Check for updates” button and updating your RouterOS software to the latest version to ensure the best performance and stability.
